I understand that an Auditor cannot limit or reduce the complete and unlimited responsibility of the Owner or the Owner's Representative as defined in 1.02.1, 1.02.2, and 1.02.3 Owner's Responsibility.

I have read and understand my obligations as set out in the Australian Sailing Special Regulations Part 2 (2005-2008), in particular Fundamental Regulations (c), (d) and (e) on page 260. I understand that any inspection is carried out only as a guide to Owners and Race Committees. An inspector cannot limit or reduce the complete and unlimited responsibility of the Owner or Owner's Representative as defined in the Fundamental Regulations. I have read and understand the Australian Sailing Recommendations. I undertake to maintain the boat and all its equipment in good order and condition as specified in these Regulations.

Where the Owner is not the Skipper I understand that the Skipper is the Owner's Representative for the time that they are in charge of the boat and that I will familiarise them with their responsibilities as stated in RRS 1 and 4 and these Special Regulations.
