Warning: If you participate in these activities your rights to sue the supplier under the Fair Trading Act 1999 if you are killed or injured because the activities were not supplied with due care and skill or were not reasonably fit for their purpose, are excluded, restricted or modified in the way set out in this notice.

Note: The change to your rights, as set out in this notice does not apply if your death or injury is due to gross negligence on the supplier's part. "Gross negligence" is defined in the Fair Trading (Recreational Services) Regulations 2004.

Exclusion of implied terms: The terms implied into contracts for the supply of services by virtue of sections 32J and 32 JA of the Fair Trading Act, are hereby expressly excluded from the provision of recreational services by Cowes Yacht Club inc to members and other participants in club activities.

ENTRY FEE: Entry fee of \$10.00 (inc GST) to Cowes Yacht Club Inc to accompany entry form and be received by Cowes Yacht Club by 1100 hours on the day of the race.

INSURANCE: All competitors are required to have personally or through their boats, Third Party Liability Insurance to a minimum of \$5,000,000 and adequate racing insurance.
